ARLINGTON NATIONAL CEMETERY (ANC), ARLINGTON, VA

PREFACE:

At approximately 0900, before the meeting was called to order, Ms. Renea Yates, the Designated Federal Officer, welcomed all members and guests on behalf of the Executive Director, Army National Military Cemeteries, Ms. Karen Durham-Aguilera and the Superintendent, Ms. Katharine Kelley, to the Honor Subcommittee of the Advisory Committee on Arlington National Cemetery's Round Table discussion on the Future Capacity of Arlington National Cemetery. She noted that ANC had provided a report to Congress pursuant to Public Law 114-158 and to ensure a common understanding, an overview presentation will be provided followed by the formal opening of the Honor Subcommittee meeting during which a Roundtable discussion of the report will be conducted. The presentation and subsequent open meeting was attended by representatives from various Veteran Service Organizations (VSO) and Military Service Organizations (MSO), as well as Congressional Staff members. Major Shannon Way, the ANC Strategic Planner then presented a report overview. The list of participants is attached to these minutes.

1. **DESIGNATED FEDERAL OFFICER'S REMARKS:** After the overview presentation and a short break, Ms. Renea Yates, Designated Federal Officer (DFO) for the Advisory Committee on Arlington National Cemetery (ACANC), opened the June 2017 Honor Subcommittee meeting. Ms. Yates noted that present in person were Major Shannon Way, ANC Strategic Planner and Mr. Timothy Keating, Alternate Designated Federal Officer. She also noted attendance by key representatives of 15 different Veteran and Military Service Organizations. Ms. Yates stated for the record that the subcommittee meeting is pursuant to the National Defense Authorization Act of 2012, codified in 10 U.S.C. § 4723. The subcommittee operates under authority and provisions of the Federal Advisory Committee Act of 1972, 5 U.S.C. Appendix 2, and 41 Code of Federal Regulation 102-3.50(d). The DFO, nominated by ANC Executive Director and appointed by the Secretary of the Army, is provided by ANC. Additionally, ANC provides administrative support to the subcommittee. Ms. Yates reminded subcommittee members not to conduct any formal business by deliberating on any substantive matters which are before the Committee as a whole for vote. Additionally, the subcommittee will report to the Committee any recommendations or information relevant as a result of the day's work. She also noted that the meeting was open to the public and after reminding the attending public that they were not generally allowed to present questions from the floor or speak to any issue under discussion by the subcommittee without permission of the Chair, she noted that the purpose of the meeting was to solicit feedback from the VSO/MSO representatives present at the

meeting. Ms. Yates also noted that the proceedings were being recorded in written form, and that minutes of the meeting will be prepared.

The meeting was called to order at 0955

2. ROLL CALL: The DFO noted a quorum for the record, with the following members in attendance:

- **PRIOR MEETING MINUTES**: The DFO announced that the minutes from the 23 January 2017 Honor subcommittee meeting were available for review in the members' binders.
- 4. CHAIRMAN'S OPENING REMARKS: The Chair thanked members of the VSOs, MSOs and Congressional staff members noting the level of participation is appreciated and that comments and discussion during the roundtable format of the meeting were welcome. Dialogue about the future of ANC with respect to possible expansion and potential changes to eligibility are sensitive issues on which the subcommittee would like to hear thoughts from VSOs and MSOs. The Chair then requested Mr. Chet Edwards, a subcommittee member and the Co-Chair of the full Advisory Committee, for remarks. Mr. Edwards echoed the Chair's appreciation to the VSOs, MSOs, and Congressional staff for attending. He noted that while the Secretary of the Army is technically empowered to decide the future of ANC, the Advisory Committee could be a means for VSO and MSO membership voices to be heard. He further said that there are no easy answers, to include doing nothing, to extend the active life of ANC for future generations. He emphasized that the current expansion achieved by the Millennium Project has been over 20 years in the making; it may require 30 or 40 years to acquire and develop new land for expansion. He stressed that no conclusions were sought in today's meeting, but a new opportunity to engage is present. He concluded by saying if ANC is to remain open "well in to the future", full non-partisan efforts are necessary. The Chair then requested the first presentation of the agenda.
- 5. INTRODUCTION TO FORESEE PRESENTATION: The DFO introduced the next agenda item stating that over the last several years, the subcommittee has been engaged in the strategic challenge of providing recommendations through the Advisory Committee to the Secretary of the Army and Secretary of Defense regarding sustaining the life of ANC as an active burial location. In February 2017, the ANC Capacity Report was submitted to Congress pursuant to Public Law 114-158. She noted that the ANC

Strategic Planner provided a foundational briefing earlier and was prepared to answer questions regarding the report as the subcommittee engages with representatives from the fifteen Veteran Service and Military Service Organizations present to engage in a round-table discussion. Before the floor was opened for discussion, it was noted that during previous discussions with VSO and MSO representatives a desire was expressed to conduct a common survey of the American people to gather a better understanding and appreciation for what our nation desires ANC to be.

In order to develop a survey as such, a presentation was made by ForeSee, an independent professional survey company that provides a metrics based survey tool. The DFO requested round table participants to wait until the entire briefing is completed before asking questions or engaging in any discussion.

The Chair then requested the presentation proceed.

- 6. FORESEE SURVEY METHODOLOGY: Mr. Mychal Graham presented information regarding Foresee survey development noting over 300 varied measurements throughout numerous Federal agencies. Additionally, he remarked that Foresee serves over 250 customers and enjoys a customer renewal rate of over 90 percent. He explained the survey development process which allows configurable models and customized questions. Model questions are designed to provide consistency, comparability and methodology tailored specifically to government requirements. Survey questions collect demographic information, purpose for visit, and other specific interests to capture participant profiling and which enhances analysis. He described various question formats including open-ended, pull-down, multi-select, radio button and skip logic. He then presented example surveys and results and presented a strawman survey being developed to canvas the public with respect to the future of ANC.
- **ROUNDTABLE DISCUSSION:** Before the Chair opened the floor to discussion, more in-depth information to supplement the overview presentation made earlier was provided by the ANC Strategic Planner, MAJ Way. As a reminder, he restated the requirement of the Public Law to consider all efforts to ensure that the maximum interment and inurnment capacity of the cemetery is not reached until well into the future.

Discussion / Comments

Various courses of action were discussed regarding changing eligibility requirements and the subsequent effects on various groups that are currently eligible and also the effect on longevity of ANC with regard to those various options. Some options for restricting eligibility, if acceptable, were shown to extend the life of ANC for hundreds of years, while other options by themselves would have a marginal effect. Further, approximately 1000 new (first internment) opportunities exist per acre of land. Based on current eligibility, given the new grave/niche burial rate of approximately 4,000 per year, each additional acre of land made available to ANC would yield three months

of longevity. Therefore, without changes to existing eligibility, extending the service life of ANC by 150 years (as the benchmark for "well into the future") requires expansion by 600 acres.

To frame the challenges associated with expansion, discussions included timelines of ongoing expansion projects with emphasis on costs compared to yield of extended life and amount of time required to accomplish an expansion. Notably, the Southern Expansion project was conceived 17 years ago and is still in the planning stages. The Millennium project efforts began during the Clinton administration and is only expected to open for burials later this year. Additionally, current expansion planning is challenged by the state of development of land contiguous to ANC. The Millennium project was developed on basically arable land, while a large area of the Southern Expansion project has major infrastructure developments which significantly increases planning and coordination time as well as expense.

The Chair concluded the discussions by reminding the participants that the day's presentations and roundtable discussions are hoped to be an initial step in establishing a national dialogue with stakeholders to increase public awareness that ANC's long-term capability and capacity require positive and innovative communications.

8. <u>MEETING ADJOURNED</u>: The Chair then called for any other business. Hearing none, he called for a motion to adjourn. The motion was made and seconded. All members voted in favor.

The National Cemeteries Act of 1973

- (b) The Administrator shall...conduct a comprehensive study of and submit their joint recommendations to Congress within twelve months after the convening of the first session of the Ninety-third Congress concerning:
- (1) whether it would be advisable in carrying out the purposes of this Act to include the Arlington National Cemetery within the National Cemetery System established by this Act;


(2) the appropriateness of maintaining the present eligibility requirements for burial at Arlington National

Cemetery; and

(3) the advisability of establishing another national cemetery in or near the District of Columbia.

SEC. 6. (a) (1) There are hereby transferred from the Secretary of the Army to the Administrator of Veterans' Affairs all jurisdiction over, and responsibility for, (A) all national cemeteries (except the cemetery at the United States Soldiers' and Airmen's Home and Arlington National Cemetery), and (B) any other cemetery (including burial plots), memorial, or monument under the jurisdiction of the Secretary of the Army immediately preceding the effective date of this section (except the cemetery located at the United States Military Academy at West Point) which the President determines would be appropriate in carrying out the purposes of this Act.

The future of our Nation's cemetery


PL 114-158, Section 2

Not later than 180 days after the date of the enactment of this Act, the Secretary of the Army shall submit to the Committees on Veterans' Affairs and the Committees on Armed Services of the House of Representatives and the Senate a report on the interment and inurnment capacity of Arlington National Cemetery, including—

- (1) the estimated date that the Secretary determines the cemetery will reach maximum interment and inurnment capacity; and
- (2) in light of the unique and iconic meaning of the cemetery to the United States, recommendations for legislative actions and non legislative options that the Secretary determines necessary to ensure that the maximum interment and inurnment capacity of the cemetery is not reached until well into the future, including such actions and options with respect to—
 - (A) redefining eligibility criteria for interment and inurnment in the cemetery; and
- (B) considerations for additional expansion opportunities beyond the current boundaries of the cemetery.

According to the Veterans Administration, there are *over 21,000,000 Veterans alive today*. ANC can only provide services for 1% of eligible Veterans or their families at their time of need.

Arlington National Cemetery will close for 1st burials — including those Killed in Action (KIA) or died on Active Duty - within the lifetime of many
of those reading this slide.








Possible eligible populations





Eligible population with 1973 policy






Eligible population with current policy






Expanding Cemetery Capacity


